

Purpose: This conference is designed to provide a comprehensive review of echocardiography and allied techniques (MRI, CT Scan, Nuclear) with emphasis on case studies dealing with valvular heart disease, endocarditis, valve repair, peripheral arterial diseases, prosthetic valves, heart failure, tumors, embolism, trauma, dissection, adult congenital heart disease, coronary artery disease, stress, 3-dimensional, LV strain/strain rate, Doppler tissue imaging, velocity vector imaging and contrast echocardiography. Special evening sessions will focus on using newer echo technologies in clinical day-to-day practice. Although the symposium is designed mainly for physicians and technologists, we invite nurses, and other health and industry professionals to attend. This Conference registration fee is free-of-charge to non-physicians and physicians-in-training however, cost of CME certificate is \$25.00. Practicing physician is \$50.00. Dinner on March 28 and continental breakfast, luncheon and refreshment breaks on March 29 are included. There are no special prerequisites.

Objectives: We expect the attendees to acquire and enhance their knowledge of various aspects of echocardiography; to be able to describe uses of basic modes of display for cardiac assessment; recognize normal anatomy and pathology of the heart from ultrasound images and to describe the use of Doppler ultrasound in the assessment of blood flow within the heart.
