### DISCLOSURE

As a provider accredited by the Accreditation Council for Continuing Medical Education (ACCME) and the American Nurses Credentialing Center (ANCC), the American College of Cardiology Foundation (ACCF) must ensure balance, independence, objectivity and scientific rigor in all of its directly provided or jointly provided/co-provided educational activities. Planners, presenters, and other contributors, in a position to control the content, are required to disclose to the audience all relevant financial relationships he/she and/or his/her spouse or domestic partner may have, occurring within the past 12 months, with any entity producing, marketing, re-selling, or distributing health care goods or services consumed by, or used on, patients. When an unlabeled use of a commercial product or an investigational use not yet approved for any purpose is discussed during an educational activity, the contributor should disclose that the product is not labeled for the use under discussion or that the product is still investigational. Should it be determined that a conflict of interest exists as a result of a financial relationship you (or spouse/domestic partner) may have, this will need to be resolved prior to the activity.

Your disclosure information will be reviewed by the Accreditation Compliance Workgroup. Staff will follow-up with you to advise if any conflicts of interest (COI) were identified, and the recommended resolution mechanisms. In accordance with ACCME and ANCC stipulations, in the unlikely event there is a refusal to disclose or inability to resolve potential COI, you will not be allowed to take part in the activity.

While your acceptance is considered pending until you complete the disclosure, you may register for ACC.18 prior to completing this step. Please note however, that registration status will be considered incomplete and meeting badge and materials will be withheld until the disclosure process has been finalized.

If you disclosed prior to March 12, 2017, you will need to update your disclosures for ACC.17.

## HOW TO REGISTER FOR ACC.18

Faculty must register for the Annual Scientific Session (staff will *NOT* automatically register you). You may register 24 hours after the time you accept your role(s).

If you accept a structured session role (e.g., presenter/co-chair/panelist) your registration fee is waived; however, the ACC does not pay an honorarium, nor reimburse for hotel, travel, or per diem expenses. If you are an abstract presenter or challenging case presenter ONLY, you must register and pay the registration fee in your respective category.
